Our Cub Scout Pack has been working on a conservation project this weekend.

We have been stenciling the message "Dump No Waste - Drains to River" next

to the storm drains in our neighborhood. The reason for painting this message is to remind adults not to dump pollutants (e.g., pesticides, herbicides, motor oil, antifreeze, paint or other chemicals) in the streets or down the drains. It has been a good experience for both the boys and adults who helped out, and I wanted to pass along some information about the

project in case others are looking for ideas.

The Storm Drain Stenciling Program is a national effort organized by the Center for Marine Conservation (CMC) in Hampton, Virginia. The CMC has lined

up local sponsors throughout the United States. In our case, we worked through the Conservation Foundation of DuPage County in Wheaton, Illinois.

The Conservation Foundation supplied the stencils and yellow spray paint at

no charge, and we divided up the neighborhood streets among our dens. It took about an hour for my son's den to complete its assigned area (40 drains). In addition, the foundation sent a representative to our last pack meeting to speak about the project and water pollution.

Participation in the project will enable our Cub Scouts to fulfill one of the requirements for the World Conservation Badge, as well as enable the pack to earn a Conservation Good Turn Award. More importantly, the boys had

fun, learned something about sources of water pollution and contributed to their community.

One of the newspapers that covers the western suburbs of Chicago (Daily Herald) ran an article about the project today. It was nice, for a change, to see a very positive story written about Scouting. We have posted a copy of the article at our web site (http://www.pack101.org/pages/herald.htm).
